### MEMBERSHIP AGREEMENT, TERMS AND CONDITIONS

This Membership Agreement ("Agreement") is entered into between Wodonga Golf Club Investment Pty Ltd, trading as Wodonga Golf Club ("Wodonga Golf Club" or "the Club"), and the individual ("Member") who submits an application for membership, renews their membership, or receives a new membership card, collectively referred to as "the Parties."

#### 1. INTRODUCTION

By submitting an application, renewing membership, or receiving a new membership card, Using Club's facility,each Member hereby acknowledges and agrees to the following terms and conditions:

- 1.1 Acceptance of Terms & Conditions: These terms and conditions represent an agreement ("Agreement") between the Member and Wodonga Golf Club, outlining the rights and obligations associated with Membership.
- 1.2 Parties: In this Agreement: "Facility" or "Club" refers to Wodonga Golf Course, located at 10 Clubhouse Place, West Wodonga VIC. "Member" refers to the individual who has agreed to the terms and conditions stipulated herein.
- 1.3 Acknowledgment and Obligations: Each Member acknowledges receipt of this Agreement and agrees to comply with all obligations outlined herein.
- 1.4 Assumption of Risk: Members attest to being in good health and capable of participating in normal exercise activities. They understand that the use of Club facilities is at their sole risk and responsibility.

#### 2. MEMBERSHIP ENTITLEMENTS

Membership at Wodonga Golf Club provide Members with only the following entitlements:

- 2.1 Use of Club Facilities: Members may use the Golf Course and the Club Facilities situated at Wodonga Golf Course, subject to any restrictions associated with their specific membership type.
- 2.2 Participation in Club Activities: Members are entitled to participate in Club matches, competitions, and Match Committees as permitted by the Club's policy, which may be subject to periodic revisions.
- 2.3 Formation of Sub-Groups: Members acknowledge that the Club is a proprietary entity owned and operated by Wodonga Golf Club Investment Pty Ltd on private land. As such, Members may not form, organize, or operate any associated sub-groups, committees, or similar entities (such as Men's groups women's groups, social committees, or other member-led associations) that use the Club's name, facilities, resources, or premises without the prior written consent of the Club's management or owners. Any such sub-group activities must align with the Club's rules, operational control, and legal obligations, including under the Corporations Act 2001 (Cth) and property law principles. Membership grants only a revocable license to use the facilities and does not confer any rights to establish independent structures or activities on Club premises without approval. Unauthorized formation or operation of sub-groups may result in termination of membership or other remedies as determined by the Club. Additionally, any fundraising or money-raising activities conducted by or within such sub-groups, whether from Club members or on Club venues, will require the Club's prior written consent to ensure compliance with applicable laws, such as the Fundraising Act 1998 (Vic), and to maintain the Club's operational and liability controls. The Club has sole discretion to not allow any fundraising activity conducted through or by Members

#### 3. MEMBERSHIP DOES NOT CONFER ANY OWNERSHIP OR OTHER RIGHTS

- 3.1 No Ownership or Interests: Members explicitly acknowledge and agree that Membership does not confer upon them any rights or interests in the Club, the Golf Course, or any of their assets.
- 3.2 No Economic or Management Rights: Membership does not grant Members the right to share in, expect to receive benefits from, or participate in the management of the Club or its facilities, including the Golf Course. Membership should not be perceived as an investment, and no financial profits or benefits should be anticipated from it.
- 3.3 Proprietary Nature of the Club: The Club is a proprietary entity owned and operated by Wodonga Golf Club Investment Pty Ltd on private land. As such, all decisions regarding the operation, management, and use of the Club's facilities and premises are at the sole discretion of the owners, and Members have no governance or proprietary rights beyond those expressly granted in this Agreement.

#### 4. NATURE OF ACCESS; PRIVATE PROPERTY; RIGHT TO REFUSE ENTRY

- 4.1 Private Property: The Club operates on privately owned land.
- 4.2 Revocable Licence: Membership grants a personal, non-transferable, revocable licence to access and use the facilities in accordance with this Agreement, Club policies, Local Rules and staff directions.
- 4.3 Right to Refuse Entry/Service: The Club may lawfully refuse entry or service to any person and may issue a trespass notice to non-members or cancelled members.

#### 5. SAFETY, LAWS & DIRECTIONS

- 5.1 Follow Directions: Members must follow all safety instructions and reasonable directions given by Club staff, contractors and officials immediately.
- 5.2 Compliance: Members must comply with applicable laws and standards (including occupational health and safety requirements), the Rules of Golf (R&A/Golf Australia), Local Rules and all posted signage.
- 5.3 Right-of-Way: Grounds/course staff, contractors, machinery and vehicles have right-of-way at all times. Do not block maintenance paths, gates or access tracks. Move aside promptly if requested.

### 6. CONDUCT & BEHAVIOUR STANDARDS

Prohibited conduct includes (without limitation):

- 6.1 Abuse/Harassment: Abusive, threatening, intimidating, discriminatory or harassing conduct toward staff, members, visitors or neighbours.
- 6.2 Unsafe Play: Hitting when people or property may be struck; entering closed areas; ignoring "no-go" zones; reckless cart use. 6.3 Obstruction: Blocking or interfering with staff operations, vehicles, gates, paths or works.

6.4 Unauthorised Activities: Commercial coaching, events, drone flight, or advertising, demonstration or selling goods/services on site without prior written approval.

Any breach of this clause may result in immediate removal from the premises, refusal of future entry, suspension or cancellation of membership.

#### 7. PERSONAL PRIVACY

The Club is committed to upholding the individual's right to privacy protection under the National Privacy Principles contained in the Privacy Act 1988. All personal information collected shall be treated with the utmost confidentiality and securely safeguarded by the Club, for use as outlined in these Terms and Conditions.

8. LIMITATION OF LIABILITY, RELEASE, AND INDEMNITY

To the maximum extent permitted by applicable law, the Club shall not be held liable or responsible to a Member for any direct, indirect, or consequential injury, loss, or damage to the Member or their property, regardless of the cause.

9. REVIEW OF CONTRACT

The Parties should carefully read and understand all the provisions within these Terms and Conditions. Wodonga Golf Club retains the right to rectify any errors or miscalculations in the Membership Application within seven (7) days following the formation of the Contract
